



Privatization of Iowa's Medicaid programs, rising prescription drug prices, and an election where the repeal of the Affordable Care Act was a major talking point were just a few of the political healthcare issues that we heard about in 2016.

Although, Community Health Free Clinic's staff and governing board continue to plan on how these issues may impact how we provide our services; we are staying focused on our mission to alleviate human pain and suffering by providing access to and delivery of compassionate healthcare. We will continue to stay the course and to take care of people as they come through our doors regardless of the political landscape outside them.

We will continue:

To provide free medical, dental, vision and prescription services, like we did this last year for over 4,700 individuals without access to or the ability to pay for healthcare in our community.

To partner with other healthcare providers and organizations to help us care for the people we serve. This year that amounted to more than \$2.1 million of in-kind services and materials.

To work with our volunteers who provided over 12,500 volunteer hours for medical services, administrative support, governance and fundraising support.

To help those patients who can't afford the medications they need. This year we provided over \$2.7 million in free medication.

To ask for the financial support of our community. This year our community supported us with over \$750,000 to provide for those in need.

Thanks to the donors, volunteers, partners, and staff on the following pages, Community Health Free Clinic will continue to stay the course and provide free medical, dental, vision, and prescription services to uninsured and underinsured patients in our community. We will also be ready to respond to whatever changes might happen that will affect people in our community's ability to receive healthcare.




